# PROCLAMATION REQUEST – BLACK HISTORY MONTH

# Recommendation

The City Clerk recommends:

- 1) That February 2005 be proclaimed as "Black History Month"; and
- 2) That the proclamation be posted on the City's website, published on the City Page, space permitting, and that staff issue a news release.

# **Purpose**

To respond to the request received from the President of the Vaughan African Canadian Association.

# **Background - Analysis and Options**

The correspondence received from the President of the Vaughan African Canadian Association, dated November 8, 2004, is attached (Attachment #1).

The Community Relations Committee at its meeting of October 13, 2004, made the following recommendation: "That the City of Vaughan proclaim February 2005 as Black History Month. (Attachment #2).

The proclamation request meets the requirements of the City's Proclamation Policy: "If the event, campaign or declaration is directly related to matters over which the City has jurisdiction or the City directly sponsors the event, campaign or other matter".

The Vaughan African Canadian Association has requested the City publicize this proclamation to promote educational, health-related, arts-based recreational and social programs to the African-Canadian community in York Region in general, and in the City of Vaughan in particular. The Corporate Communications Department posts proclamations issued by the City on the City's website under "Events – Proclamations". Publishing proclamations on the City Page depends on space availability. Corporate Communications will, given sufficient lead-time, issue news releases in support of the proclamation.

# Relationship to Vaughan Vision 2007

This report is consistent with the priorities previously set by Council and the necessary resources have been allocated and approved.

## Conclusion

Staff is recommending February 2005 be proclaimed as "Black History Month" and that the proclamation be posted on the City's website and published on the City Page, space permitting.

# Constitution/Bylaws/Policies

Art I There is established by the President and approved by the Board of Directors a not-for-profit organization which shall be called the Vaughan African Canadian Association, hereinafter referred to as VACA,

Art II Derivation of Authority: VACA derives its authority and responsibilities from this constitution, and shall be subject to its members

Art. III Purpose and responsibilities The purpose of VACA shall be:

To provide educational, health-related, arts-based recreational, and social programs to the African-Canadian community in York Region in general, and in the city of Vaughan in particular.

To promote and educate the public on the prevention of, and curative measures for, health related illnesses affecting the African Canadian community;

To educate the public and professionals on numerous issues by offering courses, seminars, conferences and meeting and by collecting and disseminating information;

To provide life-management counseling and other support services to assist members of the community;

To organize or participate in environmental projects designed to preserve, protect, and/or improve the environment in York Region;

To produce performing arts events, and hold workshops on the arts from an African-Canadian perspective for the purposes of educating and advancing an understanding and appreciation of performing arts;

To provide education, counseling and other support services for immigrants and refugees in need including language instruction, employment training, job search programs, and information programs;

To provide full-scale child and youth educational, recreational, wellness, and social arts-based programs for the African-Canadian youths in York Region;

To establish, maintain and support an office building in accordance with the purpose of the association's mandate
