Dear Councillor Carella,

The Maxey Valley Bocciofila Club Inc., one of the oldest in the City of Vaughan, has for many years enjoyed the good fortune of being able to play bocce in one of Vaughan's finest parks. We are grateful for that opportunity and, in fact, we have officially "adopted" Maxey Park for that reason. Our only regret is that the outdoor bocce season is so brief, and finding an indoor location, convenient to our members, for wintertime play is a perennial challenge

With that in mind, the Maxey Valley Bocciofila Club Inc. would like to discuss with you the following four-part proposal:

- 1. The long-term lease of one-tenth of an acre of land located enurely within the present boundaries of Maxey Park (see 'X' on the attached aerial photo). The parcel has no frontage on any roadway, but is easily accessible from the parking lot adjacent to the tennis courts at the south end of the park; it is more or less level, covered with dense brush, and some few trees.
- 2. The construction of a building on the parcel that would house four regulation-size bocccourts, two combination change/washrooms, and a small meeting room, such construction to be paid for entirely by the Club, with operational costs—heat, water, electricity, insurance, and maintenance—to be negotiated.
- 3. The provision by the Club to the City of mutually agreed upon blocks of time for the permitting of the use of the bocce courts and meeting room by the City to other recreational/social groups.
- 4. The ceding of title of the building by the Club to the City at the end of the term of the lease.

I look forward to discussing this proposal with you at your earliest convenience.
