Recommendation

The Commissioner of Finance/City Treasurer recommends that the Finance and Administration Committee adopt the following:

- 1. That, following the Finance and Administration Committee Meetings as set out in the 2011 Budget Schedule, the proposed Operating and Capital Budgets be referred to a Special Council Evening Meeting for approval, subject to final public input; and
- That the Special Council Meeting be scheduled during the week of March 28th or April 4th, subject to availability; and
- 3. That, to accommodate the notice requirements, the March 8, 2011 Finance and Administration Committee's recommendations with respect to proposed increases to the Fees and Charges By-law Number 396-2002, as amended and the proposed fee amendments to the Planning Application Fee By-law 170-2009, be referred to the Special Council Meeting to be scheduled; and
- 4. That appropriate notification be provided in accordance with the City's Notice By-law 394-2002.

Purpose

To set a date for the Special Council meeting to approve the 2011 Operating and Capital Budget and amendments to the Fees and Charges by-law and the Planning Application Fee By-law, subject to final public input.

Background - Analysis and Options

The Finance and Administration Committee has dealt with items related to the 2011 Operating and Capital over the course of 4 meetings during January and February 2011. The schedule for the remaining meetings is detailed below, with the goal of completing the 2011 budget process by the last week of March or the first week of April. In addition, on March 8, 2011, the Finance and Administration Committee will be provided with reports and recommendations from staff to amend User Fees, Service Charges and Planning application fees.

By-law 394-2002 (the City's Notice By-law) requires that the public be provided with a 14 day notice period for both adoption of budgets and amendments to fees and charges, therefore to

achieve the target budget completion date, a Special Council/Public meeting must be scheduled and appropriate notice to the public must be provided.

The following schedule identifies the 2011 budget-related agenda items that will be considered by the Finance and Administration Committee over the next several weeks, and the Special Council Meeting to adopt the 2011 budget, subject to final public input:
