The applicant is proposing an additional 18 wall signs on three wall elevations which were not approved under the original site plan agreement.

Background - Analysis and Options

Sign By-law Requirements (By-Law 203-92, as amended):

- Section 6.1 One (1) only of the following sign types per exterior wall per business premises:
 - a) wall sign
- Where a site plan approved by the City provides standards for signage and the signs for the development comply therewith, such signs shall be deemed to comply with this By-law.

Relationship to Vaughan Vision 2020/Strategic Plan

This report is consistent with the priorities previously set by Council and the necessary resources have been allocated and approved.

Regional Implications

Region of York Engineering approval is not required for the proposed signs.

Conclusion

These wall signs have been in place for years and since the Barbecue store has been in business at this premise.

If Council finds merit in the application, a Sign Permit issued by the Building Standards Department is required.



Location of sign that was approved




Langstaff Road

- 1 BBQS.com sign (to the left of the entrance) at 6' x 1'




