A By-law to amend City of Vaughan By-law 1-88. (Rom Management Inc., Z.99.030 - northwest of Highway #7 and Weston Road)

BY-LAW NUMBER 179-2001

A By-law to amend City of Vaughan By-law 1-88.

WHEREAS the matters herein set out are in conformity with the Official Plan of the Vaughan Planning Area, which is approved and in force at this time;

AND WHEREAS there has been no amendment to the Official Plan adopted by Council and not approved at this time, with which the matters herein set out are not in conformity;

NOW THEREFORE the Council of The Corporation of the City of Vaughan ENACTS AS FOLLOWS:

1. That City of Vaughan By-law Number 1-88 Exception Paragraph 9(1078), as amended by By-law 115-2000, be and it is hereby further amended by adding the following provision to subparagraph ai):

"the minimum lot area for Lots 11 and 12 shall be 280 sq.m."

READ a FIRST, SECOND and THIRD time and finally passed this 7th day of May, 2001.

SUMMARY TO BY-LAW 179-2001

The lands subject to this By-law are located northwest of Highway #7 and Weston Road being Block 24, Plan 65M-3084, in Lot 7, Concession 6, City of Vaughan.

The purpose of this By-law is to add the following paragraph to subsection ai):

"the minimum lot area for Lots 11 and 12 shall be 280 sq.m."

This paragraph was inadvertently omitted when By-law 115-2000 was originally prepared. The Planning Staff report acknowledges the need for exception to lot area.
