# Purpose

To enact a by-law to change the name of Valdorr Avenue to Orr Avenue.

# **Background – Analysis and Options**

At its meeting of April 15, 2002, Council directed staff to commence procedures as required by the Municipal Act to advertise and schedule a Public Hearing to change the street name of Valdorr Avenue to Orr Avenue. This change is necessary to provide an appropriate level of emergency service.

The notice was advertised for four (4) consecutive weeks in the City Page of the Vaughan Citizen and the Liberal (Thursday edition only). Affected property owners were notified. No objections were received.

# **Conclusion**

In order to complete the road name change process, Council's approval of this recommendation is required. The By-law will be brought forward to the Council meeting of June 24, 2002 for enactment.

The Commissioner of Engineering and Public Works, in consultation with the Directors of Purchasing Services and Reserves and Investments recommends:

- That a contingency allowance in the amount of \$13,000.00 be approved, within which the Commissioner of Engineering and Public Works or his designate is authorized to approve amendments to the Contract;
- 3) That should staff identify the need to provide walkway lighting at additional locations, staff be authorized to have Pine Valley Landscaping complete this work at the same unit prices tendered up to the approved Capital Budget funding of \$200,000 for Project No. 1110.4 within the available approved Capital Budget funding; and
- 4) That the Mayor and Clerk be authorized to sign the necessary documents.

# <u>Purpose</u>

Council approval to award contract T02-020.

#### **Background - Analysis and Options**

The work covered by this tender (Capital Budget project No. 1110.4) includes the supply and installation of walkway lighting at twenty-four walkway locations throughout the City. (See Attachment No. 1).

Tenders closed for this project on Wednesday, May 15, 2002 and the ten low bids received are listed as follows:

Staff have thoroughly reviewed and assessed the bids. Pine Valley Landscaping and its electrical subcontractor Cobra Power have completed parks and lighting contracts for the City and other municipalities with satisfactory results. Therefore, staff recommend that tender T02-020 be awarded to Pine Valley Landscaping (1998) Ltd.

The estimated cost of the project including a contingency allowance and all applicable taxes is \$145,000.00 and is calculated as follows:

Pine Valley Landscaping (1998) Ltd.	\$123,579.00 (excluding G.S.T.)
Contingency Allowance (10%)	\$ 13,000.00
G.S.T. (3%)	\$ 4,097.37

The total available Capital Budget funding (Project No. 1110.4) is \$200,000, therefore sufficient funding is available in the approved Capital Budget to complete this project.

Engineering staff have recently reviewed and updated the City's 1995 walkway inventory and lighting needs assessment. Additional walkways have been identified which were not included in the original inventory. Staff therefore recommend that additional walkway locations be lit this year by extending this contract and fully utilizing all the available funding. Funding to complete any remaining walkways will be proposed for the 2003 Capital Budget program.

# **Conclusion**

The contract be awarded to Pine Valley Landscaping (1998) Ltd.
