#### **Recommendation**

The Director of Finance in consultation with the Manager of Property Tax and Assessment recommends that the tax adjustments as outlined on the attached report be adopted.

#### <u>Purpose</u>

To obtain Council approval for the increase, cancellation, reduction, or refund of taxes.

#### **Background - Analysis and Options**

Several applications for cancellation, reduction, or refund of taxes for the 2000, 2001, and 2002 tax years under Sections 442 and 443 of The Municipal Act, R.S.O. 1990, as amended have been prepared for Council's consideration.

There are <u>28</u> applications under consideration at this time. There are various reasons for tax cancellations, such as a result of properties becoming exempt, buildings that have been demolished or razed by fire, and properties that have been over assessed by a gross or manifest clerical error.

The total cancellation, reduction, or refund of taxes, as recommended, is <u>\$148,759.45</u>. The City portion of this amount is approximately 20%, or <u>\$29,751.89</u>. Please note that the tax adjustments relating to commercial and industrial properties are prior to any recalculations resulting from the capping legislation.

Two applications have been prepared under Section 444 of The Municipal Act, R.S.O. 1990 for Council's consideration.

The first property, municipally known as 4850 King-Vaughan Road, Assessment Roll Number 19.28.000.400.02000.0000, application number 992, was originally assessed at \$149,400 (farmland) and \$919,600 (residential). The 2002 assessment was returned incorrectly at \$919,600 (farmland) and \$149,400 (residential). This application is to amend the clerical error made by the Municipal Property Assessment Corporation. The recommended 2002 tax increase on this application is **\$9,281.91**.

The second property, municipally known as S/S Komura Road, Assessment Roll Number 19.28.000.233.39500.0000, application number 993, had the 2002 assessment returned at \$19,237. This value is the apportioned value and not the CVA value for 2002. The actual assessment should have been returned at \$1,674,000. The recommended 2002 tax increase on this application is **\$19,920.56**.
