**PROPOSED HIGHWAY 400 OVERPASSES IN BLOCKS 32 AND 33**

The Committee of the Whole recommends:

- 1) That in anticipation of an amendment to Official Plan 600, staff be directed to prepare terms of reference for a study on the implications of deleting or not constructing the Highway 400 overpass in Block 32, and the study must identify alternatives to the construction of the overpass and provide details of the costs and their implications on the road network and Vaughan residents;
- 2) That the Region of York be requested to fast track the road improvements and construction of Weston Road, Rutherford Road, Major Mackenzie Drive, Langstaff Road, Pine Valley Drive, and Teston Road with the full interchange;
- 3) That the terms of reference be brought to Committee of the Whole for approval, as soon as possible;
- 4) That the matter be referred to a Budget Sub-Committee meeting, as soon as possible, for discussion regarding the funding and timing for the study;
- 5) That the following report of the Commissioner of Planning and the Commissioner of Development Services and Public Works, dated May 27, 2002, be received; and
