Recommendation

The Commissioner of Legal and Administrative Services recommends that the Proclamations Policy be amended by inserting the following clause defining the intent of the phrase "municipal purposes", as referred to in the Proclamations Policy:

"That the City of Vaughan may issue proclamations for events, campaigns or other similar matters where there is a municipal purpose and the municipality has jurisdiction over the matter. A municipal

purpose shall be restricted to and include only special events, fairs, campaigns, special declarations of days, weeks, months, or otherwise where:

- (i) the event, campaign or declaration is directly related to matters over which the City has jurisdiction or,
- (ii) the City directly sponsors the event, campaign or declaration".

Purpose

To define the intent of the phrase "municipal purposes" as referred to in the Proclamations Policy.

Background - Analysis and Options

Prior to November 23, 1998, all requests for Proclamations were received by the Mayor and were forwarded to the Clerk. The requests would be placed before Council in a report prepared by the Clerk recommending approval. Council would authorize the issuance of proclamations and no proclamation request was refused. A great many proclamations were issued taking up staff time.

On November 23, 1998, Council adopted a policy that the City would issue no proclamations. Requests were received by organizations which were directly related to the City's municipal jurisdiction. On April 2, 2001, Council amended the policy that the City would issue proclamations only for events of a municipal purpose.

Council, at its meeting of December 16, 2002, reconfirmed the policy and asked that staff provide a report defining the intent of the phrase "municipal purposes", as referred to in the Proclamations Policy after considering the New Municipal Act.

Conclusion

By defining "municipal purposes" in the Proclamations Policy, the City Clerk can now determine which requests for proclamation can be considered. The definition will confine all proclamations only to events which are initiated by the municipality itself or related to municipal jurisdiction such as Municipal Engineering, Roads, Fire and Emergency Services, Municipal fairs, etc.

Recommendation

The Commissioner of Community Services, in consultation with the Executive Director of Buildings, Facilities and Parks Department and the Director of Purchasing Services recommends:

- 1. That bid T03-099 for Maple Community Centre Expansion be awarded to Maystar Construction in the amount of \$5,601,450.00 and.
- 2. That contingency allowance in the amount of 10% be approved, within which the xecutive Director of Buildings, Facilities and Parks is authorized to approve amendments to the Contract;
- 3. That the Mayor and Clerk be authorized to sign the necessary documents.

Purpose

To award Tender T-03-099 for the expansion of Maple Community Centre.

Background

The Maple Community center was built in 1990 and is unable to accommodate the need of a fast growing community. A feasibility study was conducted in 2001, to determine the need for the expansion of the Maple Community Centre. The analysis of this study was to determine how to improve and expand the facility, and provide concept plans on how the expanded areas could be accommodated as part of the existing community center. The process also included public consultation and input from City of Vaughan staff.

The study concluded that the center needed to be expanded, in particular the following areas:

- 1. Fitness Area.
- 2. Program Space used by youth groups
- 3. Children Activity Room
- 4. Bocce Facility/Space used by seniors
- 5. Improvement to the exterior site and basement area

In addition, council also approved the creation of an area dedicated to an "Italian Interpretive Centre" to be included as part of the proposed expansion.

Staff issued an RFP for the works included in the feasibility. RFO02-105 was awarded to Intra Architects Inc. in June 2002.

Staff issued an RFP for the pre-qualification of general contractors in December, 2002. Twenty-five 25) documents were received, and nine (9) companies pre-qualified.

T-03-099 was issued to the nine (9) companies that pre-qualified.

The bids closed on May 21, 2003, four (4) bids were received, results are as follows:

Staff reviewed the submissions and found that Maystar General Contracting was the low bidder and their bid meets the specified requirements.

Conclusion

Maystar General Contracting have performed similar work for the City. Staff are satisfied that they can complete the work. Staff anticipates work will commence as soon as the contractor is awarded.
