Economic Impact

Purpose

The purpose of this report is to request direction from Council regarding appointment of members to the Accessibility Advisory Committee.

Background - Analysis and Options

The Vaughan Accessibility Advisory Committee has been experiencing difficulty obtaining quorum and several consecutive Committee meetings have been cancelled due to lack of quorum. With the resignation of two members, Ms. Mira Miller-Coullard and Ms. Meenu Sikand, and the quorum issue, the Committee was not able to fulfill the requirements mandated by the *Ontarians with Disabilities Act, 2001*, and requested direction by Council.

At the Council meeting of December 12, 2005, Council approved that the positions of Mira Miller-Coullard and Meenu Sikand be declared vacant, and that the City Clerk be directed to advertise for additional members to the Accessibility Advisory Committee. Advertisements were placed in the local newspapers, the Vaughan Citizen/Liberal, the Tandem and the Vaughan Weekly. Advertisements were also placed on Vaughan's City Page, requesting that residents interested in being considered for appointment complete an application and submit it to the Clerk's office. The deadline for receipt of applications was Friday, February 17, 2006. Copies of applications have been provided to Council and it is requested that Council review the applications and provide direction with respect to appointments to the Accessibility Advisory Committee.

Relationship to Vaughan Vision 2007

This report is consistent with the priorities previously set by Council and the necessary resources have been allocated and approved.

Conclusion

Interested City of Vaughan residents have submitted applications to be considered for appointment to the Accessibility Advisory Committee. It is requested that Council provide direction respecting the appointments.
