## **Background - Analysis and Options**

The correspondence received from the Chairperson, The York Centre for Children, Youth & Families, dated April 6, 2010 is attached. (Attachment)

The proclamation request meets the City's Proclamation Policy, as follows:

"That upon request, the City of Vaughan issue Proclamations for events, campaigns or other similar matters:

(i) Which are promoted by any organization that is a registered charity pursuant to Section 248 of the Income Tax Act"

The York Centre for Children, Youth & Families, comprised of 3 children's mental health agencies in York Region (Blue Hills Child & Family Centre, Kinark Child & Family Services and The York Centre for Children, Youth & Families) has requested that the City publicize this proclamation. The York Centre for Children, Youth & Families have scheduled a variety of activities to increase public awareness of children's mental health issues, encourage parents to seek help, promote and maintain good mental health, and provide contact information for children's health services in York Region. Council in previous years have granted this proclamation request.

#### Relationship to Vaughan Vision 2020/Strategic Plan

This report supports the strategic priorities established by Vaughan Vision 2020, in particular "Enhance and Ensure Community Safety, Health and Wellness".

## **Regional Implications**

This proclamation will bring awareness of children's mental health issues within the Region.
