145. PAY DUTY OFFICER AT THE INTERSECTION OF KIPLING AVENUE / COLES AVENUE / HAWMAN AVENUE

That the following be approved:

- 1) That due to the safety concerns created by the occupation of the west boulevard of Kipling Avenue between Coles Avenue and Highway 7 and the imminent start of the 2010/11 school year which will result in school children having to cross Kipling Avenue to walk along the sidewalk on the east side, staff are directed to implement a pay duty officer at the Kipling Avenue / Coles Avenue / Hawman Avenue intersection;
- 2) That the pay duty officer is to be implemented for the start of the upcoming school year and until a permanent solution can be found; and
- 3) That the cost of the pay duty officer is to be paid by the developer at 7730 Kipling Avenue, Trimax Developments, and the requirement shall be a condition of any encroachment permit issued for this site.
