- 3. That the donation be absorbed through the Council Corporate Budget.

Economic Impact

In 2010 the Council Corporate Budget has already absorbed a donation of \$10,000 to the Haiti Earthquake Relief Fund and \$10,000 to the Pakistan Flood Relief. It is anticipated that this donation of \$10,000 can also be absorbed by the Council Corporate Budget.

Communications Plan

If the recommendation is approved, Corporate Communications will issue a Media Release.

Purpose

To donate \$10,000 to the Haifa Foundation Emergency Appeal in response to the disastrous forest fires raging in Haifa and in support of the large Israeli community in Vaughan.

Background - Analysis and Options

A disastrous forest fire has raged through the Carmel Forest, south of Haifa. The damage is still being assessed, but to date 12,500 acres have been lost, 17,000 people have been evacuated, 15 settlements and towns have been evacuated, and the estimated damage is at \$1 billion.

The Canadian Committee for the Haifa Foundation is appealing for help to support the City of Haifa during this emergency (Attachment 1). Funds are being raised to purchase hygiene kits, bedding, communication equipment, fire retardant uniforms and helmets, and security vehicles. The Canadian Committee for the Haifa Foundation provided a list of specific items needed as part of the emergency relief effort (Attachment 2). The City's donation letter can specify exactly which items we would like the donation to go towards.

The City of Vaughan does have a history of donating funds for international disasters. Past donations include \$5,000 to the Canadian Red Cross China Earthquake (2008), \$10,000 to the Abruzzo Earthquake Relief Fund (2009), \$10,000 to the Filipino Canadian Association Philippines Relief Fund (2009), \$10,000 to the Haiti Earthquake Relief Fund (2010) and \$10,000 to the Humanity First Pakistan Flood Relief (2010). In addition, the City of Vaughan has an International Partnership Program with the City of Ramla, Israel.

This report is consistent with the priorities previously set by Council and the necessary resources have been allocated and approved.

Dear Friends.

As a result of the disastrous forest fire that has raged through the Carmel Forest south of Haifa, there is much need and our community is responding. Firefighters gained control over the wildfire in the Carmel on Sunday, after four days of battling the flames that caused the deaths of 42 people, including Haifa's deputy police chief, Ahuva Tomer. 17,000 people have been evacuated from nearby settlements, including students and teachers from the University Of Haifa. 12,500 acres have been lost, 5 million trees burnt, 15 settlements and towns have been evacuated. The damage is only now starting to be assessed, but it is estimated to be at a billion dollars.

Our Committee is asking you to help support the City Of Haifa during this emergency. Our first concern is for the safety of all the citizens of Haifa and the surrounding neighbourhoods. We have been asked by the City of Haifa to raise funds to buy hygiene kits for thousands of the evacuated families, bedding, communication equipment, fire retardant uniforms and helmets for an additional 100 fire fighters, and security vehicles. These items and the costs associated with them are all listed on our website. Contributions will be also needed to rehabilitate thousands of acres of forest that have been lost. The Israel Fire Departments were found to be woefully lacking in manpower, equipment and even the vital chemical suppressants for blocking the fire from spreading. For the first time, an Israeli Prime Minister had to appeal for foreign assistance to cope with the national disaster. The Haifa Foundation has also been called upon to assist in raising funds to build a larger and more efficient fire truck brigade, so that the Fire Department in Haifa can combat future emergencies more effectively.
