### **BY-LAW NUMBER 30-2011**

A By-law to amend the Consolidated Traffic By-law 284-94, as amended, to govern and control traffic in the City of Vaughan. (Ravineview Drive and Peak Point Boulevard/Beaverbrook Crescent)
