The Committee of the Whole (Public Hearing) recommends:

- 1) That the recommendation contained in the following report of the Commissioner of Planning, dated May 15, 2012, be approved;

That staff examine decreasing the height maximums at the Centre Street frontage in the Mid-Rise Mixed Use B designation (Site 2) from 6 storeys to 4 storeys in order to provide a more appropriate transition to the low-rise residential area to the north, given the limited lot depths in this stretch of the Centre Street corridor;
 - 2. That staff also examine the designation of the building identified as "M" in the Site 1 area located immediately south of the bulb of MacArthur Avenue, from a maximum of 8 storeys to 6 storeys;
 - 3. That staff, in light of the significant intensification already in place in the area, provide a strategy on how to develop a comprehensive and holistic approach to the further development of the Centre Street Corridor from Bathurst to Dufferin Streets, including the areas as far north as New Westminster Drive (at Bathurst Street) and the Promenade lands to the south; and
