## **Background – Analysis and Options**

The City of Vaughan's Civic Hero Awards honour individuals who make our community a better place in which to live and work. As a young twenty-something Tom Lazenkas was working on Danforth Avenue in the City of Toronto's east end forty years ago when he took a call from friend George Tsigoulas, who told Tom that he had just leased a small building in Woodbridge, for a barbershop for the two of them. Tom's first response was "Where's Woodbridge?"

The shop had in fact been in operation for more than a third of a century, having been open originally in 1935 by barber Ali Robb. Back then (and until 1972) Woodbridge Avenue was known as Pine Street, and the small parkette immediately to the west of the shop was the village's police station.

Fast forward to 2009, when Tom will be marking his fortieth anniversary as Woodridge's premier barber on October 13. While the Royal Bank of Canada (once housed in what later served as the municipal offices of the Village of Woodbridge, and as the Woodbridge Public Library ever since), the Bank of Montreal, and the Ministry of Transportation office pre-date Tom's arrival in Woodbridge, none of the personnel at these locations has his track record in terms of local service.
