### **ALTAMIRA CHARITY CHALLENGE GOLF TOURNAMENT PROPOSED PARKING RESTRICTIONS/ROAD CLOSURE**

#### **Recommendation**

The Commissioner of Development Services & Public Works recommends:

That on Monday July 2, 2001 between the hours of 7:00a.m. and 8:00 p.m. Clarence Street be closed from Meeting House Road to Wycliffe Avenue; and

That on Monday, July 2, 2001 between the hours of 7:00 a.m. and 8:00 p.m. parking of motor vehicles be prohibited on the streets or portions of streets shown below:

- 1) Waymar Heights Boulevard;
- 2) Davidson Drive;
- 3) Park Drive;
- 4) Rosewood Court;
- 5) Rosebury Lane;
- 6) Meeting House Road;
- 7) Norton Place;
- 8) Clarence Street from Woodbridge Avenue to Meeting House Road;
- 9) Woodbridge Avenue from Islington to Clarence Street;
- 10) Lloyd Street;
- 11) Wakelin Court;
- 12) Arbors Lane; and
- 13) Gamble Street.

#### **Purpose**

To authorize the temporary thirteen hour long road closure and temporary parking restrictions, as requested by Mr. J. Beauchemin, Clubhouse Manager (Operations), The Toronto Board of Trade Country Club in a May 2, 2001 letter to J.D. Leach, City Clerk.

#### **Background - Analysis and Options**

The Toronto Board of Trade Country Club will be hosting the Altamira Charity Challenge Golf Tournament on Monday, July 2, 2001. About 5,000 spectators are anticipated due to celebrity golfer participation in this professional/amateur tournament. A temporary closure of Clarence Street is needed to alleviate concerns about safe crossings and security.

Staff also recommends that temporary parking restrictions be implemented on nearby local streets. These prohibitions will allow unrestricted access to the residential streets by any required emergency service, and reduce parking impacts on local residents.

Parking for this event will be provided internal to the Toronto Board of Trade Country Club site. Access to the site's parking area will be provided off Meeting House Road and emergency vehicle access will be allowed in the parking area.

Due to the road closure of Clarence Street, the Toronto Board of Trade Country Club will pre-notify the residents on Clarence Street, Modesto Gardens and Cromdale Ridge.

**Conclusion**

That Council adopt an appropriate by-law to authorize the above described temporary road closure and parking prohibitions.

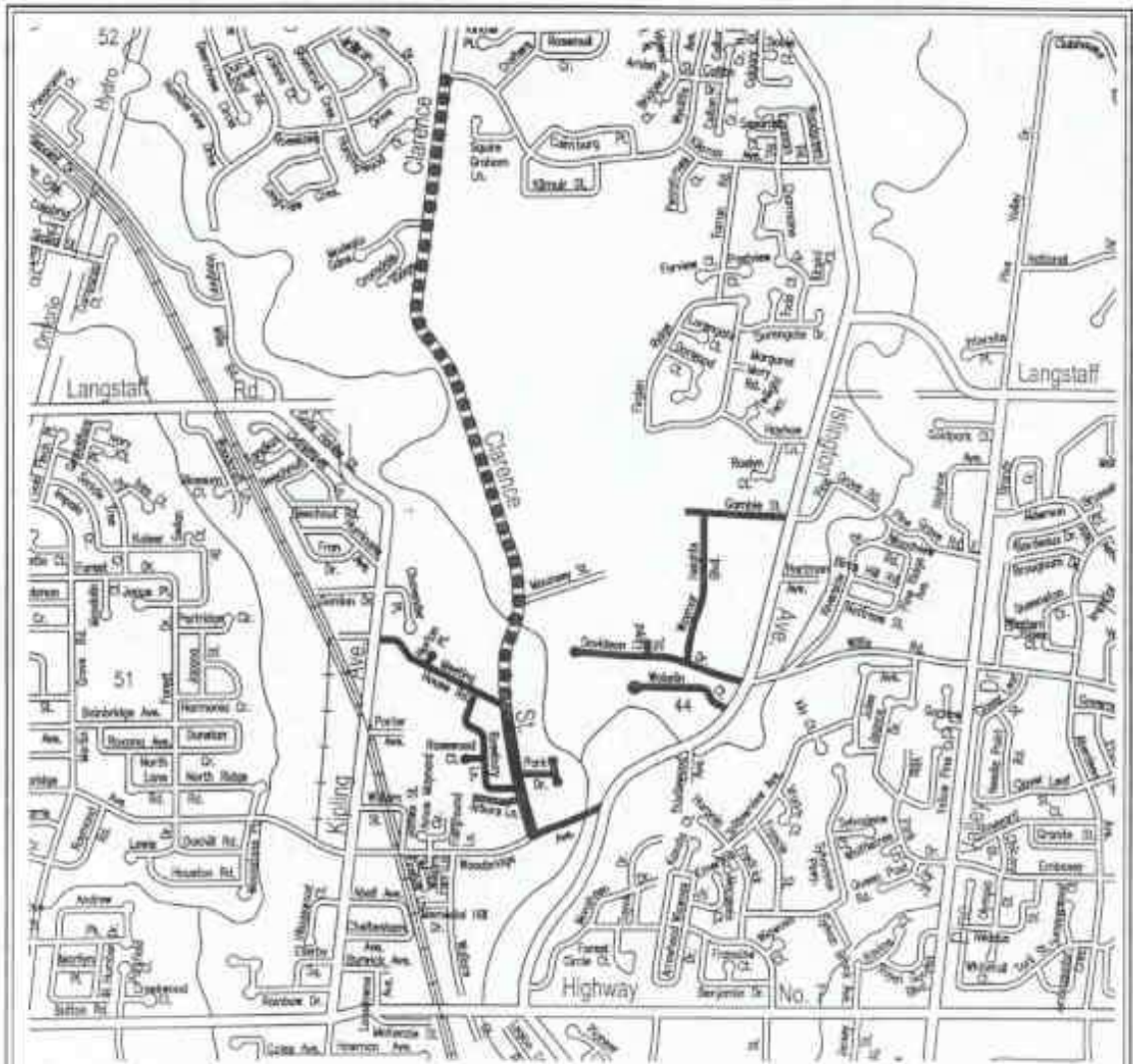
