**Purpose**

The applicant has submitted street names for approval pursuant to Condition #7 (19T-99V10) and Condition #6 (19T-00V22) of Draft Plan Approval.

**Background - Analysis and Options**

The City of Vaughan recommended draft approval for 19T-99V10 on February 12, 2001 and for 19T-00V22 on June 25, 2001. The Planning Department for the Region does not have any objections to the proposed names.

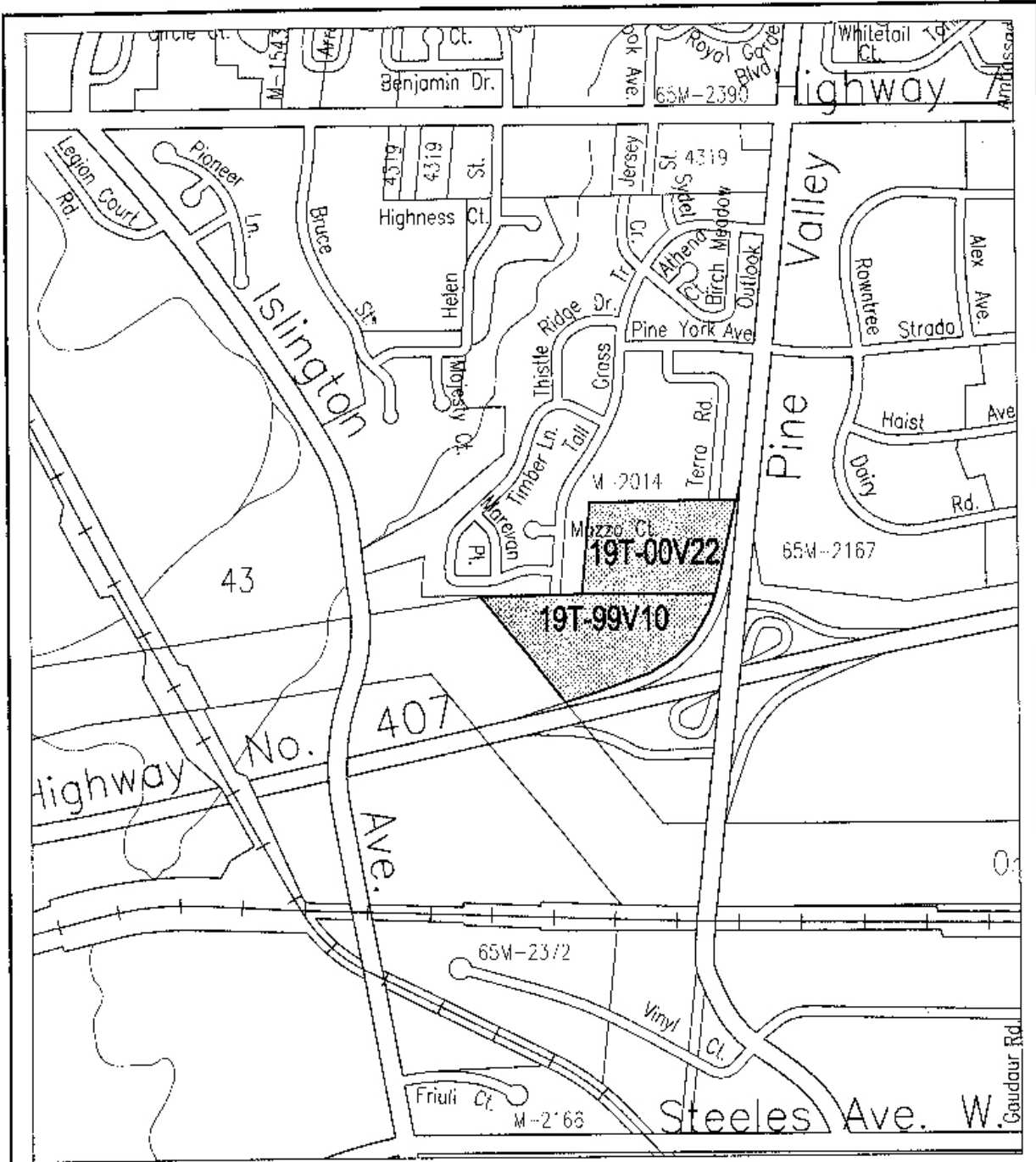

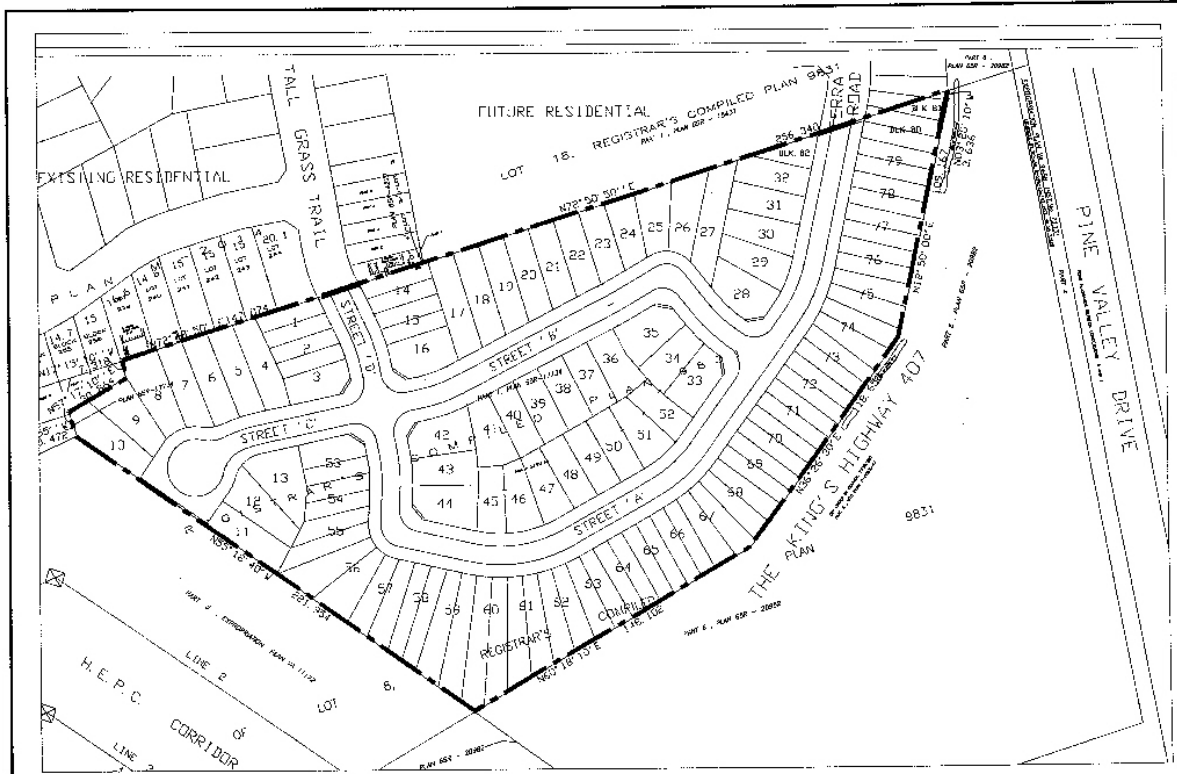

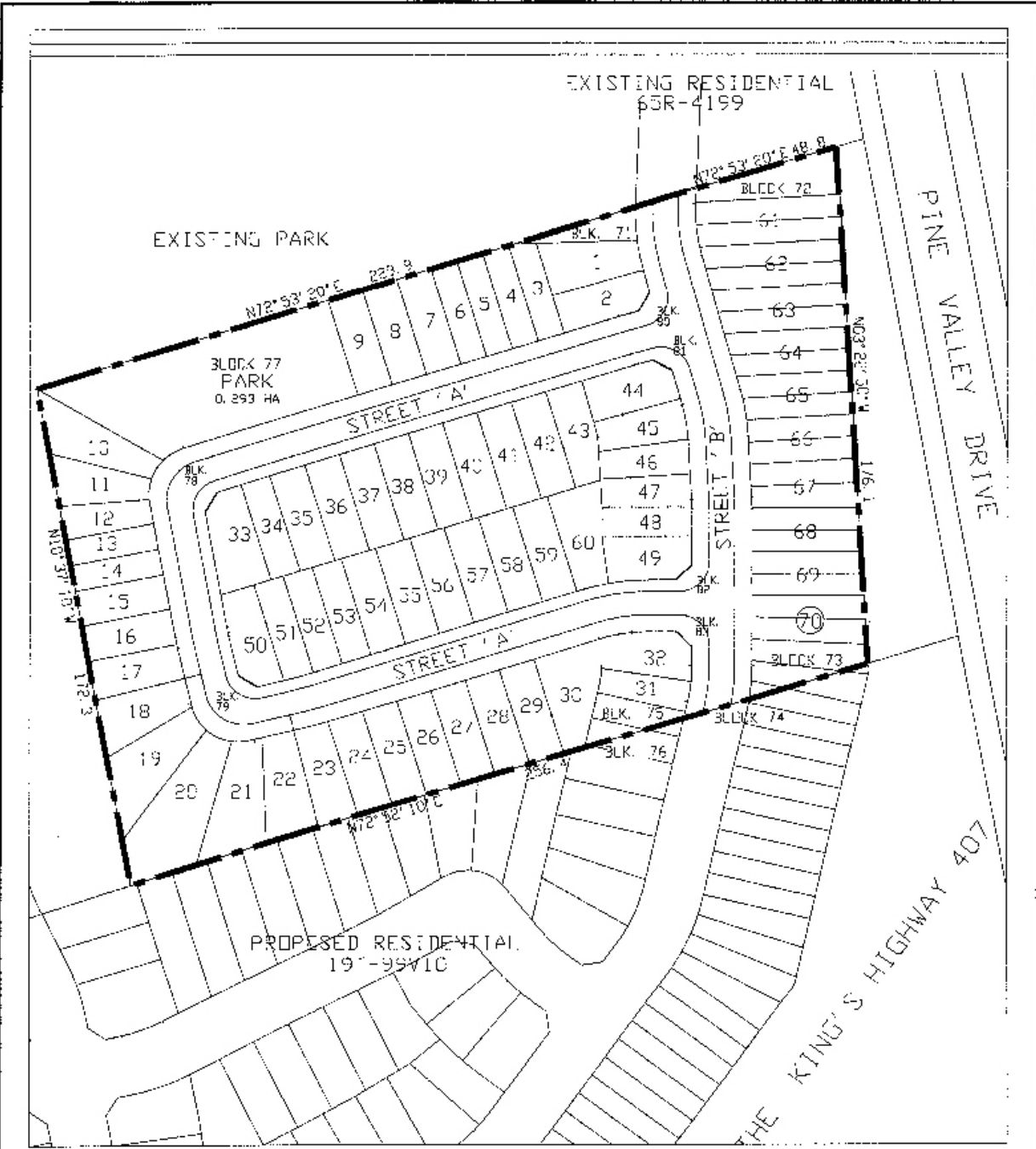
