Recommendation

Purpose

Background - Analysis and Options

The Municipal Act requires that the Treasurer of every municipality submit to Council a Statement of Remuneration and Expenses paid to the Members of Council and Council appointments to other bodies. The Municipal Act R.S.O. 1990, Chap. M.45, as amended Sections 242, 243, 244, 245 and 247 provides authority for the Remuneration and Expenses to Council, Boards and other Bodies.

The Remuneration and Expenses for Council are authorized by By-law Numbers 62-2000 as amended by 69-2001. The remuneration of Members was authorized by Council By-law Number 103-2001 for the Committee of Adjustment and By-law Number 100-2001 for Non Profit Housing and By-law Number 95-2001 for Heritage Vaughan.
