# SITE DEVELOPMENT FILE DA.02.012 ATLAS COLD STORAGE CANADA LIMITED

## **Recommendation**

THAT the building elevations for Site Development Application DA.02.012 (Altas Cold Storage Canada Limited) BE APPROVED.

## Purpose

On February 25<sup>th</sup>, 2002, the Owner submitted a Site Development Application for an addition to the west side of the cold storage facility (9564.58 sq.m) to accommodate a freezer (3847.84 sq.m), dock/engine room (698.12 sq.m) and office (614.92 sq.m).

# **Background - Analysis and Options**

The 3.61 ha site is located west of Weston Road, on the south side of Highway No. 407 (316 Aviva Park Drive), being Blocks 10 and 11 on Registered Plan 65M-2790, in Lots 2 and 3, Concession 6, City of Vaughan.

The proposed addition is 18.8m in height, which is between the original building of 22m and the previous addition of 16.6m.

The north and west additions are identical to the existing building, and will be treated with prefinished stucco and embossed metal-clad freezer panels in a bone-white colour. The 1.8m wide, charcoal-coloured horizontal accent band will be continued along the midway point of the entire building and the roofline of the west elevation.

The south (front) elevation, in addition to the white insulated metal paneling, consists of a charcoal-coloured split-face concrete block, which wraps around to the west elevation to match the existing engine room and office area. Pre-finished charcoal siding is proposed above the eight loading doors. An additional entrance is located on the south elevation, and a window strip is located above the loading dock area.

The rooftop mechanical equipment will be screened with pre-finished metal paneling to match the building façade. No additional signs are proposed on the building. The height variation, together with the continued accent banding and extensive landscaping adjacent to Highway No. 407, will assist to diminish the massing of the relatively large and modest looking building.

### **Conclusion**

Staff is satisfied with the proposed building elevations. Should the Committee concur, the recommendation in this report can be adopted.
