AWARD OF TENDER T03-035 **SUPPLY AND DELIVERY OF VARIOUS PICKUP TRUCKS**

Recommendation

The Commissioner of Community Services, in consultation with the Executive Director of Buildings, Facilities and Parks, the Director of Purchasing, and the Director of Reserves and Investments recommends:

1. That Part "A" of Tender T03-035, for the supply and delivery of two (2) ½ ton 4x2 pickup trucks, be awarded to Northtown Ford Sales Ltd. for a total price of \$50,105.50. Projects 4988-0-03 / 4887-0-03; and,
2. That Part "B" of Tender T03-035, for the supply and delivery of two (2) compact size 4x4 pickup trucks, be awarded to Addison on Dundas Ltd. for a total cost of \$51,890.30. Projects 5032-0-03 / 5031-0-03; and,
3. That Part "C" of Tender T03-035, for the supply and delivery of two (2) midsize, 4x4 pickup trucks, be awarded to Davidson Chrysler for a total cost of \$57,343.60. Projects 4905-0-03 / 4906-0-03; and,
4. That Part "D" of Tender T03-035, for the supply and delivery of three (3) ¾ ton HD crew cab 4x2 pickup trucks, be awarded to McAlpine Ford Lincoln sales for a total cost of \$99,015.00. Projects 4879-0-03 / 4877-0-03 / 4989-0-03; and,
5. That Part "E" of Tender T03-035, for the supply and delivery of three (3) compact size 4x2 pickup trucks, to be awarded to Alex Irvine Motors Ltd. for a total cost of \$65,139.45. Project 5039-0-03; and,
6. That Part "F" of Tender T03-035, for the supply and delivery of one (1) ¾ ton cargo van, be awarded to Maclver Dodge Ltd. for a total cost of \$25,675.05. Project 4883-0-03; and,
7. That Part "G" of Tender T03-035, for the supply and delivery of four (4) ¾ ton regular cab 4x4 pickup trucks with snow plows, to be awarded to McAlpine Ford Lincoln sales for a total cost of \$145,176.00. Projects 4986-0-03 / 4990-0-03 / 5019-0-02.

Purpose

To award tender T0-035 for the supply and delivery of various pickup trucks.

Background – Analysis and Options

Council approved funds to purchase various pickup trucks as part of the ongoing equipment program. These projects were approved in 2003, as part of the capital budget and are funded from the Vehicle Reserve Fund, Development Charges and Taxation.

This tender was advertised in the Liberal and the Electronic Tendering Network (ETN), with twenty seven (27) bid documents issued and sixteen (16) received on closing date, March 27, 2003. In Part "A" one (1) bidder was noncompliant and one (1) bidder was noncompliant in all cases. The result of the bids including GST and PST are as follows:
