# ENGINEERING CONSULTANT FOR THE DESIGN AND CONTRACT ADMINISTRATION OF THE CONCORD FLORAL DAM OBSTRUCTION REMOVAL

## Recommendation

The Commissioner of Engineering and Public Works in consultation with the Director of Purchasing Services and the Director of Investments and Reserves recommends:

- That notwithstanding City Purchasing Policies and Procedures, the City retain Dillon Consulting Limited for the design and construction of the Concord Floral Dam Obstruction Removal work at an estimated cost of \$43,000 plus G.S.T.; and
- That a contingency allowance in the amount of \$4,000 plus G.S.T. be approved, within which the Commissioner of Engineering and Public Works or his designate is authorized to approve.

# <u>Purpose</u>

To retain Dillon Consulting Limited for the design and construction of the Concord Floral Dam work.

## **Background - Analysis and Options**

At its meeting of October 15, 2001, Council approved Contract T01-153 for the Construction of the Creditstone Road Bridge, subject to the receipt of Toronto Region Conservation Authority (TRCA) and Department of Fisheries and Oceans (DFO) approval. (Refer to Additional Information Item No. 19, Report No. 61, Council, October 15, 2001 – Attachment 2).

As part of the TRCA and DFO approval, the realignment of the West Don River at the bridge crossing requires a fisheries compensation plan that includes on-site realignment works and offsite dam removal works at the Concord Floral Dam to compensate for fish habitat impacts as a result of the construction of the new bridge structure.

Dillon Consulting was responsible for the design of the creek realignment at the Creditstone Road bridge crossing and the Fish Habitat Compensation Plan Report that was approved by TRCA and DFO. Phase I of the Plan, which included the creek realignment at the bridge crossing, is now complete as part of the bridge construction which was completed in 2002. Phase II of the Plan includes the compensation work required at the Concord Floral Dam and must be completed in 2003.

Dillon has provided a written work plan to the City dated January 31, 2003 for the design and construction (including DFO reporting requirements) of the Concord Floral Dam Obstruction Removal project in the amount of \$43,000, plus G.S.T. Staff have reviewed the workplan and cost estimate and find it to be reasonable and consistent with the preliminary cost estimate in the 2001 report (refer to Attachment 2). Due to their involvement in the design and construction inspection and approvals for this project, staff recommend that Dillon be further retained to complete this work.

Sufficient funds are available for the completion of this component (design and construction) of the project, funded from 2001 Capital Budget Project No. 1298-1-01 (funded from City Wide Development Charges).

# **Conclusion**

It is cost effective to retain Dillon Consulting Limited for the design and construction of the Concord Floral Dam remedial works.



### Purpose

Council approval to award Contract T01-153 for the construction of the Creditstone Road Bridge.

#### Background - Analysis and Options

The work covered by this tender (Capital Budget Project 1298.1) calls for the construction of Creditstone Road Bridge, south of Rutherford Road, as per Attachment No. 1. Also included in this project is the construction of watermain, storm sewers, realignment of the West Don River at the bridge crossing, and a proposed fisheries compensation plan that includes on-site realignment works and off-site dam removal works (Concord Floral Dam) to compensate for fish habitat impacts as a result of construction of the new bridge structure at this location.

A key factor influencing the commencement of construction is the granting of approvals by the Toronto Region Conservation Authority (TRCA) and the Department of Fisheries and Oceans (DFO) for realignment of the watercourse and to place road approach fill in the valley. Applications and supporting documentation have been submitted by the City's consulting engineers to the TRCA and DFO. Staff have requested that the TRCA complete their review, including the coordination of DFO review, and report to the TRCA Executive by the November 1, 2001 meeting at the latest. The award of this contract should not be made until TRCA and DFO approvals have been secured.

## Conclusion

The 2001 Capital Budget Project 1298.1 includes a total of \$2,800,000 for the construction of the Creditstone Road Valley Crossing, funded from City Wide Development Charges – Engineering.
