#### SPRINGSIDE PARK - PROPOSED RENAMING

#### Recommendation

The Director of Recreation and Culture recommends:

THAT Springside Park be renamed to Brett J. Yerex Park in memory and recognition of Mr. Brett J. Yerex's commitment to the quality of life in Vaughan.

# Purpose

The purpose of this report is to obtain Council approval to rename Springside Park in memory of Mr. Brett J. Yerex.

#### **Background - Analysis and Options**

The City of Vaughan received correspondence from the Maple Landing Ratepayers Association dated May 12, 2004 requesting that Springside Park be renamed in memory of Mr. Brett J. Yerex (refer to Attachment 1).

The City of Vaughan's Policy (No. 04.3.08) for Renaming City Parks, Open Spaces, Community facilities and Other Municipal Buildings and Properties allows for name designation in honour of individuals or groups providing the any of the following criteria is demonstrated:

3.3 Criteria/Guidelines for Names Honouring Individuals or Groups

"Names for consideration shall be those of distinguished persons, organizations, corporations, foundations or the families:

- 1. where there has been a significant contribution to the quality of life, well-being of the City of Vaughan and is consistent with Vaughan Vision; or,
- 2. to memorialize or otherwise recognize substantial gifts and significant donors, individuals designed by donors, or individuals who have made exemplary or meritorious contributions to the City of Vaughan; or,
- 3. where there is a strong historical or cultural connection to the City and has made a major contribution to the historical or cultural preservation of the City; or,
- 4. where there is a strong contribution toward the environmental preservation, conservation or enhancement of the City; or,
- 5. where there is a major contribution made to the acquisition, development or conveyance of land or building, in question and/or its subsequent development; or,
- 6. where there is a direct relationship or association that exists between the place or former place of residence of the person or group and the facility/park/street to be named.

The Department of Recreation and Culture supports the renaming of Springside Park in memory of Mr. Brett J. Yerex for the considerable contribution to improving the quality of life and well being to the residents of Vaughan. Over the years Mr. Yerex volunteered his time to numerous community initiatives and was most recently involved as a member of the newly formed Vaughan Accessibility Advisory Committee.

# Relationship to Vaughan Vision 2007

This report is consistent with the priorities previously set by Council and the necessary resources have been allocated and approved.

# Conclusion

Staff recommend that Springside Park be renamed to Brett J. Yerex Park in memory and recognition of Mr. Brett J. Yerex's commitment to the quality of life in Vaughan.

One of Brett's proudest moments was being awarded the Queen's Golden Jubilee Medal (see http://www.tkg.ca/mainpages/byerek.htm) for his many contributions to his community.
