Purpose

To provide an analysis and summary report of Vaughan's economic conditions, development trends and the activities of the Economic & Technology Development Department.

Background - Analysis and Options

The year 2004 was an active year for the Vaughan business community. In addition to a robust real estate market, the number of firms and employment grew by 9% and 11%, respectively. Development and construction in the industrial and commercial sectors continued to be strong, despite a slight decline in the overall value of construction.

The Economic & Technology Development Department expanded its mandate in 2004. In addition to business attraction, retention and small business development activities, the Department also undertook steps to develop programs in the Environmental and Tourism sectors. These new initiatives required the involvement and participation of public sector agencies and private sector partners.

The Annual Report provides a summary of the Department's activities as well as an analysis of the economic conditions that will impact local businesses as they plan and prepare to meet the challenges of local and global competitiveness. Preparation of the Annual Report was delayed due to staffing constraints. However, the importance of the Annual Report as year-to-year reporting mechanism and as a marketing and research tool for site selectors, realtors and investors, compelled the completion of this document. Hence, this popular document has been posted on the City's website as well as being forwarded to federal, provincial and regional agencies.

Relationship to Vaughan Vision 2007

The Annual Report meets Goal 6.4 of Vaughan Vision 2007 to create increase awareness of the City's leadership on key issues and celebrate our successes and achievements. This report is consistent with the priorities previously set by Council and the necessary resources have been allocated and approved.

Conclusion

The Annual Report documents the achievements of the Economic and Technology Development Department, but more importantly, it demonstrates to future investors the dynamic nature of our community.



Industrial and Commercial Land Absorption 2000-2004



Vaughan Business Enterprise Centre

 S_{Vaughan} and have traditionally been the largest employment generators.

Vaughan Business Enterprise Centre (VBEC), a part of the Economic & Technology Development Department, helps businesses to grow and expand, while simultaneously supporting new entrepreneurial enterprises and providing consultations and professional development for small business owners. The services include "take-home" information packages on starting a business, group training and Individual consultations. Founding partners include the Province of Ontario through the Ministry of Economic Development & Trade (MEDT) and the City of Vaughan. Private sector partners include RBC Royal Bank, Scotlabank, BMO Bank of Montreal, Business Development Bank of Canada, and CIBC.

Some of the milestones achieved at VBEC over the past year:

- over 18,000 clients serviced
- in excess of 3,000 business consultations
- more than 1,300 new business registrations
- creation of more than 1,500 initial jobs from registered businesses
- 227 visits to the Resource Library
- 372 seminar attendees
- 164,46]3 website hits

On average, newly-created businesses registered through VBEC in 2004 were expected to generate more than \$13 million in initial investments.

Bridge to Better Business Event

In celebration of small business month in Ontario, VBEC hosted its 3rd Annual Bridge to Better Business Event in October. Over 130 business people and dignitaries met for a day of celebration and networking. Attendees took the opportunity to listen to dynamic speakers as they shared innovative strategies and solutions that could be implemented in their daily business and personal lives. The keynote address came from gardening guru and entrepreneur, Mark Cullen.

The Summer Company initiative in its 4th successful year at VBEC is a program open to both high school and post-secondary students. During the fall, students compete for the chance to receive a grant of up to \$3,000 to start their own summer business by submitting an award-winning business plan. In 2004, five enterprising young people were awarded with the Summer Company grants towards their business ventures.


Expected Initial Investment by Business

VBEC, 2004




New Business Registration by Industry

Business Growth

Employment

Employment Survey 2004

Employment growth in Vaughan continues to be strong. Vaughan experienced an overall growth of II% in employment from 2003. Approximately I50,000 individuals are employed by Vaughan companies. The number of businesses operating in Vaughan grew by 9%, now numbering more than 8,000 businesses.

All but one sector experienced overall growth in employment. The most prominent sectors continue to be Manufacturing, Construction, Retail Trade and Wholesale Trade. In particular, the Professional, Scientific and Technical Services and Retail Trade sectors showed large increases at 42% and 29% growth, respectively. Transportation & Warehousing companies continue to be the most significant single employers, maintaining a level of 40.3 employees per business. Manufacturing also maintains a significant level at 34.0 employees per business.








Environmental Brochure wins recognition from EDCO . . .

On June 2, 2004 the City of Vaughan in cooperation with York Region Health, the Clean Air Partnership and the TRCA/Kortright Centre, organized and hosted the York Region Sustainable Communities Forum. The event was very successful with 57 people in attendance. Corporate sponsorship of \$2600 was raised for the event.

Smog Summit 2004

On June 21, 2004, the City of Vaughan Joined approximately 20 municipalities and senior levels of government in making commitments to reducing smog by signing the Inter-Governmental Declaration on Clean Air at Smog Summit V.

Energy & Environmental Innovations Workshop

The City of Vaughan sponsored and hosted the Energy & Environmental Innovations Workshop held on November 16th at the Copper Creek Golf Course. This workshop provided public sector and industry decision-makers with information on government funding programs and case studies of proven environmental technologies.





New Indianas Tourism

In late 2003, Mayor Michael Di Biase and Vaughan Council directed that the Economic/Technology Development department add tourism development to its departmental mandate by providing support to businesses in the tourism segment of our local economy. After extensive consultations with representatives of the local tourism industry, the Vaughan Tourism Advisory Committee (VTAC) was formed in June 2004, to advise the City on strategies and issues pertaining to this vibrant industry in Vaughan.

VTAC's membership is comprised of business operators and representatives from the tourism sector in Vaughan and is co-chaired by Ward 2 Councillor Tony Carella and Diana Dodge of the Dodge Suites Hotel.

In September 2004, the very successful first **Annual Discover Vaughan Bash** was held at the Paramount Event Venue in Woodbridge

with more than 400 people in attendance. Net proceeds of more than \$140,000 provided the seed monies needed to proceed with securing an external consultant to

conduct a Tourism Study and subsequent development of a Vaughan Tourism Strategy. This work began in November 2004 and is expected that a Strategy will be delivered by June 2005.
