HAWKVIEW BLVD. – SIDEWALK REVIEW

Purpose

Residents are requesting that a sidewalk be installed on Hawkview Blvd.

Background - Analysis and Options

Councillor Bernie DiVona has received the above referenced request by the residents of Hawkview Blvd. Vellore Woods. They have expressed the dire need for a review to address safety issues.

Hawkview Blvd. has been constructed to serve as a mid block collector based on comments from the Engineering Department.

Hawkview Blvd. has a sidewalk constructed between Weston Road and Vellore Blvd. However, there is no continuous sidewalk easterly.

Hawkview Blvd. appears to have the same road width and residents had felt that there should be a consistent use and municipal service delivery.

Residents also wish to walk from Hawkview Blvd. to Rutherford Road and Weston Roads as shopping malls exist. Currently, they have to walk on the road for some of the way on the same street. This problem is aggravated in cold weather or rainy conditions which adds to pedestrian safety.

Lastly, residents have expressed concern as the road as a curve and it is dangerous for children to cross or use the road with vehicles swerving around them at high speeds.

NEIGHBOURHOOD SAFETY: PETITION REQUEST FOR SIDEWALKS

We, the concerned residents of Hawkview Blvd., are petitioning regarding neighbourhood safety. We need your help Mr. DiVona. Our goal is to enhance street safety -- we need sidewalks. Being the chair of the Safe City Committee, you understand our strong concern in this matter. The residents have signed the petition below supporting our need for sidewalks.

<u>About Hawkview:</u> Hawkview Boulevard is one of the main Boulevards (arteries) for the Vellore Woods Area. Hawkview connects to several roads such as: Sunview Drive, Vellore Woods Boulevard, Osprey Drive and Timberland Drive. Sadly, there are no sidewalks for such a busy Boulevard.

<u>Current Problem</u>: Children, residents and families are made to walk on the street, vehicles <u>swerve</u> to bypass them; this is completely unsafe. In the winter, there is no safe zone for children or adults to walk. The situation gets worse when the streets are plowed, as the street turns narrow. The icy roads are dangerous for vehicles and even increasingly dangerous for young children to walk on.

Solution: Mr. DiVona, our subdivision is assumed and we desperately need sidewalks on the **south/east-side** of Hawkview Boulevard (opposite the residents' homes on vacant land), **East** of **Veliore Woods Bivd**. We've attached a map for your review. Please help us get this process started.

Why are sidewalks important:

- Sidewalks provide a safe and level walkway, especially during wet weather and for people using wheelchairs, the elderly, or people pushing a cart or stroller. For these people, it is particularly important that sidewalks have well-designed curb ramps and level driveway crossings.
- Sidewalks provide safe places for children to walk, run, skate, ride their bikes, and play.
- Sidewalks significantly reduce pedestrian collisions with motor vehicles: For instance, one study
 found that in residential and mixed residential areas, pedestrian crashes were more than two
 times as likely to occur at locations without sidewalks than would be expected on the basis of
 exposure.
- Sidewalks improve the ability for people to get around by providing ways for them to get wherever they need to go: work, parks, schools, shopping areas, transit stops, and home.
- · Sidewalks enhance the appearance of neighborhoods and the entire community.
- Sidewalks provide separation between motor vehicles and pedestrians.
