Epilepsy York Region, a registered charity, dedicated to promoting epilepsy awareness, is seeking assistance in raising awareness of this disease. Epilepsy is one of the most common neurological conditions which is estimated to affect over 50 million people worldwide and over 300,000 people in our country. Proclaiming "Purple Day" is a global effort celebrated annually to increase understanding, reduce the stigma and improve the quality of life for people with epilepsy. Council has previously granted this proclamation.
