WHEREAS the Oak Ridges Moraine Protection Act, 2001 impacts on land within the City of Vaughan;

AND WHEREAS the extent of the impact and the meaning and intent of the Act require clarification;

AND WHEREAS the City of Vaughan recognizes that prospective homeowners, businesses and landowners at varying stages of development approvals are affected by the Act;

AND WHEREAS there is clarification required with respect to Section 6 regarding the application of the Act to a concession lot where part of the lot includes the moraine;

AND WHEREAS clarification is required as to what procedures and related activities by municipalities and their staff are prohibited by the Act;

NOW THEREFORE COUNCIL RESOLVES:

THAT the Ministry of Municipal Affairs and Housing be requested to provide clarification as to the lands affected and the procedures and actions by municipalities and their staff prohibited by the Act as soon as possible;

AND THAT this resolution be circulated to the Regions of Peel, York and Durham and the local municipalities affected by the legislation.
