1 APPOINTMENT TO THE VAUGHAN HEALTH-CARE FACILITY STUDY TASK FORCE

The Committee of the Whole (Closed Session) recommends:

- 1) That Mr. Suleiman Rashid, MBA, CA, be appointed to the Vaughan Health-Care Facility Study Task Force; and
- 2) That the confidential report of Mayor Di Biase, dated June 21, 2004, be received.

2 DIRECTION TO PREPARE A REQUEST FOR EXPRESSION OF INTEREST <u>DEVELOPMENT OF THE CIVIC CENTRE SITE</u>
