1 MAYOR'S TASK FORCE ON SAFETY AND SECURITY IN VAUGHAN

The Committee of the Whole (Closed Session) recommends:

- 1) That the City of Vaughan form a Mayor's Task Force to develop recommendations regarding Safety and Security by focusing on education, prevention and community participation;
- 2) That Mr. Julian Fantino be appointed as the Task Force Chair;
- 3) That the Chair appoints the Task Force members with representation from key stakeholder groups;

Recommendation

Mayor Michael Di Biase recommends:

- 1) That the City of Vaughan form a Mayor's Task Force to develop recommendations regarding Safety and Security by focusing on education, prevention and community participation;
- 2) That Mr. Julian Fantino be appointed as the Task Force Chair;
- 3) That the Chair appoints the Task Force members with representation from key stakeholder groups;
- 4) That the Task Force develop and recommend Terms of Reference to Council at the earliest opportunity;
- 5) That staff support be provided to the Task Force and that a budget of \$5,000 be provided from the Council Corporate budget if required.

Economic Impact

The impact is \$5,000 within the existing budget.

Purpose

To create a Mayor's Task Force with the objective of developing recommendations which, when implemented will improve community safety.

Background - Analysis and Options

The City of Vaughan is not isolated. We are an intricate part of the GTA and not immune to the issues that face the City of Toronto and other GTA communities. In recent months we have been witness to various acts which undermine the safety and security of our community; however the City, on its own cannot take on this challenge. We must involve our whole community and key stakeholders in order to improve safety in our community. That is why I am recommending that a Mayor's Task Force be established. The Task Force will include representatives of key stakeholder groups. Key stakeholders include the City of Vaughan, York Regional Police, the Vaughan business community, School Boards and prominent community organizations in Vaughan. It is only through working together that we can find and implement solutions.

Public input and timing will be important to the success of the Task Force. The Task Force will be charged with the responsibility of recommending to Council the Terms of Reference which will outline in more detail, the mandate of the Task Force, the process for obtaining public input and the timely reporting of recommendations.

Should Council endorse this initiative Mr. Julian Fantino has offered to serve as the Task Force Chair. He is currently the Commissioner of Emergency Management for the Province of Ontario and a resident of Vaughan. Formerly he was the Chief of Police for York Region and more recently the former Chief of the Toronto Police Services. His understanding of the community and his expertise in community safety make him ideally suited to Chair this important Task Force.

Relationship to Vaughan Vision 2007

This report is consistent with the priorities previously set by Council and the necessary resources have been allocated and approved.

3 COMMUNITY RELATIONS COMMITTEE ADDITIONAL MEMBERS

- 1) That five (5) representatives be added to the Committee as voting members, being one from the separate school board, one from the public school board, one from the York Regional Police, one from the Youth Cabinet and one from the Vaughan Seniors' Association; and

The City Clerk recommends that direction be provided with respect to the Community Relations Committee recommendation for additional members from the Separate and Public School Boards (one member from each Board), York Regional Police (one member), Vaughan Youth Cabinet (one member) and SAVI (one member).
