Purpose

The purpose of this report is to request that Council appoint six additional members, being business representatives, to the Village of Woodbridge Quasquicentennial Committee. Background - Analysis and Options

The establishment of the Village of Woodbridge Quasquicentennial Committee was approved at the Council meeting of June 27, 2005. The Committee will plan the celebration in 2007 of the 125th anniversary of the incorporation of the Village of Woodbridge as a municipality. Clerks recruited for members in November 2005 and six members were appointed at the Council meeting of December 12, 2005 (membership list attached).

At the Council meeting of January 16, 2006, Council further approved that Councillor Carella recruit six business representatives from Woodbridge to serve on the Committee in addition to the appointed individuals. Six business individuals are being presented for appointment to the Village of Woodbridge Quasquicentennial Committee, and it is requested that the appointed business members be permitted to send authorized designates on their behalf, to attend and participate as members at Committee meetings, as necessary.

Relationship to Vaughan Vision 2007

This report is consistent with the priorities previously set by Council and the necessary resources have been allocated and approved.

Conclusion

As approved by Council on January 16, 2006, six business individuals are being presented to Council for appointment to the Village of Woodbridge Quasquicentennial Committee. It is also requested that the appointed business members be permitted to send authorized designates on their behalf, to attend and participate as members at Committee meetings, as necessary.
