- 1) That the recommendation contained in the following report of the Commissioner of Planning, dated April 24, 2007, be approved;**
- 2) That the Official Plan Amendments for the four identified area studies be provided as soon as possible;**
- 3) That the Province of Ontario and The Region of York be advised that it is Vaughan Council's preference that the Highway 427 extension be aligned along the hydro corridor to the greatest extent possible;**
- 4) That the Yonge Street corridor be included as a separate study, and that staff provide a report with the terms of reference and a budget for the study;**
- 5) That the presentation of the Director of Policy Planning/Urban Design and the Senior Planner, Policy Planning and Urban Design, and presentation material submitted entitled, "Towards a New Official Plan for Vaughan" and the Draft Work Plan Schedule, be received; and**
- 6) That the written submission of Ms. Rosemarie L. Humphries, Humphries Planning Group Inc., 216 Chrislea Road, Suite 103, Woodbridge, L4L 8S5, dated April 21, 2007, be received.**

That Staff initiate the process to retain the required consulting services to develop the Official Plan; and

That the 2007 Capital Budget include an allocation of \$750,000 to fund the work associated with the Official Plan process for the year 2007.
