The Committee of the Whole (Closed Session) recommends:

- 3) That the report of the City Clerk, dated February 20, 2006, be received.**

Recommendation

The City Clerk recommends:

- 1) That the positions of Stephen Lecce and Anna-Lisa Lombardi be declared vacant; and
- 2) That direction be provided with respect to the Vaughan Youth Cabinet's request to fill the vacancies with Nicole Damiano and Adriano Volpentesta.

Economic Impact

There is no economic impact as a result of this report.

Purpose

To request that the positions of Stephen Lecce and Anna-Lisa Lombardi be declared vacant and receive direction regarding the Vaughan Youth Cabinet's request to fill the vacancies with Nicole Damiano and Adriano Volpentesta.

Background - Analysis and Options

At the Vaughan Youth Cabinet meeting of February 1, 2006, discussion ensued regarding Members that have missed three (3) consecutive meetings. Clerk's staff at the meeting advised that the City Clerk, at the request of the Cabinet, had sent correspondence to these Members reminding them of the attendance policy and requesting they advise the Clerk's Department as soon as possible if they are able to continue their appointment on the Cabinet. It is noted that no responses to the Clerk's letter, written or verbal, have been received to date.

Council's policy regarding attendance states "If a member is absent from meetings of the Committee for three (3) consecutive regularly scheduled meetings, or in the opinion of the Committee if any member's absenteeism jeopardizes the objectives of the Committee, the Committee shall pass a resolution requesting Council to appoint a replacement member".

Although the Cabinet was sympathetic to the possible reasons for the Members' difficulty in attending meetings, they were of the opinion that their continuous absence would cause lack of quorum, which in turn would present considerable delays in the objectives, and initiatives of the Cabinet. At the February 1, 2006 meeting, a motion was made, and duly carried, to remove Stephen Lecce and Anna-Lisa Lombardi from the Vaughan Youth Cabinet membership, and requesting that Nicole Damiano and Adriano Volpentesta, volunteers who have been actively
